# Who Benefits from Marriage Penalty and Child Tax Credit Relief in H.R. 6: Estimates by State and Congressional District

On March 29, the U.S. House of Representatives passed H.R. 6, the Marriage Penalty and Family Tax Relief Act of 2001, by a vote of 282–144. The legislation, sponsored by Representative Jerry Weller (R–IL), proposes tax relief for millions of American families by alleviating part of the marriage penalty and expanding the child tax credit in the current Internal Revenue Code. The Senate is expected to begin debate soon on its own marriage penalty and child tax credit legislation.

Using data from the 1990 Census, the Internal Revenue Service, and Congress's Joint Committee on Taxation, analysts in the Center for Data Analysis have found that over 25 million married taxpayers would benefit from marriage penalty reform and about 40 million children would be eligible for the expanded child tax credit. Table 1 shows these estimates by state and congressional district.

Marriage Penalty Relief. H.R. 6 would eliminate the bias in the standard deduction against married couples by increasing the

standard deduction for married couples to twice that of single taxpayers. Currently, two single unmarried workers who live together can each claim the standard deduction of \$9,100 in 2001, while a married couple is allowed a standard deduction of \$7,600.

H.R. 6 addresses the inequities in the marginal tax rate structure of the current income tax code by doubling the 15 percent rate bracket of joint filers to twice that of single filers. For 2001, the threshold of the 28 percent bracket is \$45,200. H.R. 6 would increase this threshold to \$54,100, saving married couples almost \$1,200 in taxes.

H.R. 6 also proposes relief for low-income working families by increasing the income phaseout for the Earned Income Tax Credit (EITC) so that low-income married couples would not lose as much of their credit as they do now simply because they are married. <sup>1</sup>

 CDA analysts estimate that more than 25 million married taxpayers would benefit from the marriage penalty relief. Table 1

shows the number of couples by state and congressional district who would benefit from the proposals in H.R. 6.

The Child Tax Credit. H.R. 6 also would expand the child tax credit, which became a part of current federal tax policy through the Taxpayer Relief Act of 1997 (P.L. 105–34). The current credit allows qualified taxpayers to reduce their tax liability by \$500 for each dependent in the home under the age of 17.

The current child tax credit is refundable against FICA deductions only for families with three or more qualified dependents. H.R. 6 would expand the credit to \$1,000 and allow all families to claim the refundable portion of the child tax credit. This policy would significantly increase the number of taxpaying families who would benefit from the credit.

 CDA analysts estimate that over 40 million children would benefit from the expanded child tax credit. Table 1 shows estimates of the number of children in each state and congressional district who would be eligible for the credit.

#### **METHODOLOGY**

Table 1 of this *CDA Report* shows estimates of the number of married taxpaying couples who are affected by the marriage penalties inherent in the income tax code's standard deduction, marginal tax rates, and phaseout ranges of the Earned Income Tax Credit (EITC). The vast majority of these couples are two-earner families in which the second earner's wages are a significant portion of the family's income. This analysis cannot be used to estimate the dollar amount of penalty per family due to differences in the marginal rate structure and the EITC. Some married couples pay more as a marriage penalty because of the differences in the rate brackets and the loss of credits.

CDA analysts used the March 1999 Bureau of the Census Current Population Survey, which contains 1998 income data, to determine the number and type of families that pay the marriage penalty in each state.<sup>2</sup> The 1995 IRS Public Use File was used to determine how many families typically used the standard deduction instead of itemizing their deductions in each tax bracket.<sup>3</sup> A couple are assumed to pay a penalty if they had two earners in a tax bracket higher than 15 percent or are likely to use the standard deduction in the 15 percent bracket. Married families receiving the EITC pay a penalty in terms of a faster phaseout; they are also assumed to incur a marriage penalty. The number of families who do not currently receive the EITC but would if they were both single was not used in this analysis.

CDA analysts used the 1990 Census report to estimate the percentage of families incurring a penalty at the congressional district level; these were the most recent data available at the congressional district level. The percentage of families likely to suffer a penalty was held constant for families in 1998. The 1995 IRS Public Use File was used to determine the likelihood of couples in each state paying a marriage penalty. The overall number of families affected in 1998 was taken from the Joint Committee on Taxation's estimate of 25 million.

The analysts used the March 2000 *Current Population Survey* to estimate the number of children who would benefit from the child tax credit. Children under the age of 17 with tax liability were assumed to be potential beneficiaries of the increase in the child tax credit. The tax credit was used to reduce federal tax liability to zero and, in some cases, to reduce the FICA taxes paid by families with eligible children. Many families do not receive the full value of the credit because their

tax liability is eliminated before the total amount of the tax credit can be claimed.

CDA analysts estimated the number of children in each congressional district using the 1990 Census report, which listed children and their family's income by congressional district. <sup>8</sup> The

ratio of dependents eligible for the credit was held constant from the 1990 Census.
