## MAYOR PRO-TEM, THREE OTHERS ARRESTED ON ELECTION FRAUD CHARGES

Douglas Mayor Pro-Tem Olivia Pearson and three other local residents were arrested on Tuesday, May 31, on charges related to election fraud after recently being indicted by a Coffee County Grand Jury. Charlie Mack Wooten, James Curtis Hicks and Evelyn Griffin were the others arrested.

All four individuals were indicted by a Grand Jury on Wednesday, May 25, and the charges are related to alleged election fraud committed during the November 2012 General Election. Pearson, Wooten, Hicks and Griffin were all granted present bonds.

An investigation conducted by the Georgia Secretary of State's Office revealed that Pearson, Wooten, Hicks and Griffin "did in fact provide assistance to electors who were not physically disabled or illiterate." The investigation also revealed that some poll workers failed to mark on some voter certificates the reason for assistance when Olivia Pearson assisted the voters.
