
Dear Mr. Quester:

This letter is in response to your request for information on cases of vote fraud in Oklahoma. Enclosed is information from the Oklahoma State Courts Network on a recent case in Adair County. The defendant Darryl Cates entered a plea of nolo contendere and received a deferred sentence of three years. The charges of false notarization of absentee ballots related to activities in the Cave Springs School District Election held on February 10, 2009.

As Assistant Secretary Fran Roach explained on the telephone, the State Election Board does not have records on all prosecutions for vote fraud, and there is no central repository for that information. I have enclosed listings for each of the 27 District Attorneys in Oklahoma, including their contact information.

Please feel free to contact the State Election Board again if we may be of further assistance.

Cite as: 26 O.S. § 16-103 (OSCN 2012)

Any person who knowingly swears or affirms a false affidavit in order to become eligible to vote, to obtain and vote a provisional ballot, to obtain and vote an absentee ballot, or to cause the cancellation of a qualified elector's voter registration, shall be deemed guilty of a felony.
