This is important because we are trying to discern where in the election process the fraud is predominantly occurring.

Is there a chance you could give me the statute or code the people in this list were accused of? Are there any other contextual pieces of information that we could attach to these names?

Good morning Sarah. I have done quite a bit of research determining what information we could find on voter fraud cases. I discussed this with our Records Manager after she returned from vacation. Attached is an index of cases since 2007. We did not maintain a searchable record prior to 2007 so the only way we would be able to locate cases is if you had names or other information for us to search for those cases. If any cases exist prior to 2007 they are unidentifiable records.

Of the list attached above all cases have been declined (not prosecuted) except one. The defendant on the one case we prosecuted and sentenced on March 25, 2010, receiving a sentence of 20 Days jail converted to 160 hours of Community Service. The charge was Voting Fraud RCW 29A.84.130(1), a felony. The election was the 2008 general election. Defendant name is Janice Marie Waters. (see top of list page 3 for more case information).

Please acknowledge receipt of this e-mail and the attached documents. This will close your request since we have no further responsive documents.
