FROM THE CHAIRMAN

he past year has been one of transition in the country, little of it good.

We saw the left take over the White House and Congress and bungle everything they touched. We have an economy in the grip of rising inflation and chronic shortages, a nation weakened internationally by the disastrous retreat from Afghanistan, a border in chaos, and draconian COVID mandates that inflict more harm than good. The left tried to make election fraud easier (in the guise of voting rights), to vastly expand the soul-destroying welfare state (under the cheery label of Build Back Better), and to push Marxist critical race theory on our kids (in the name of fighting racism).

It was also a year of transition at The Heritage Foundation, as President Kay C. James and Executive Vice President Kim R. FROM THE PRESIDENT

hen I was in eighth grade, my family relocated from Louisiana to the D.C. area in the wake of the 1980s oil bust. That was the first time I encountered The Heritage Foundation.

As a brash teenager from a working-class family, I'd gotten into a debate with my left-of-center civics teacher. I've long forgotten what it was about, but I never forgot what he said to me, because it

had such a profound effect on my life. "You might make something of yourself," he said, "if you attach evidence to your opinions." My mother recommended we go to The Heritage Foundation, which had established itself as the go-to resource for conservatives, to gather up materials they put together.

From that moment on, I'd never again offer an opinion on any topic without the facts to back it up. I grew up trusting the unimpeachable quality of Heritage's scholarship, which would serve me well throughout my life as a historian, founder of a private K-12 school in Louisiana, president of Wyoming Catholic College, and head of the Texas Public Policy Foundation.





A POWERHOUSE TEAM LEAVES THE STAGE

When Heritage was searching for a new president in 2017, the Board of Trustees tapped Kay C. James to lead the search.

But James' lifetime of experience, her boundless optimism, her unbridled passion for Heritage and conservatism so impressed the board that they asked her to serve as Heritage's sixth president.

After a career in the private sector, government, and philanthropy, James agreed to take the job—with the specific goal of positioning Heritage for far greater success in the future. Over the course of nearly four years, James proved the board's judgment absolutely correct.

As president, James led the organization to a period of influence over public policy and brought her private sector experience to strengthen Heritage's operations, putting in place a multi-year strategic plan, zero-based budgeting, enterprise-wide risk management, customer service training, and much more.

One of James' great passions was reaching out and sharing Heritage's message with young people, minorities, and women who don't necessarily consider themselves conservative but who practice conservative principles in their daily lives.

When COVID sent the nation into a tailspin, James organized the National Coronavirus Recovery Commission, giving states a roadmap to successfully reopening their economies. At the same time, she offered other conservative organizations assistance on fundraising, communications, and managing during times of crisis to help them weather the COVID storm.

In all of this, James was aided by Kim Holmes, who served as her executive vice president. Holmes joined Heritage in 1985 and rose to vice president in 1991. He managed the defense and foreign policy team for more than two decades and was a founding editor of the influential Index of Economic Freedom (see page 27).

During President George W. Bush's first term, Holmes served as assistant secretary of state for international organization affairs at the U.S. State Department. When he returned to Heritage in 2005, he wrote the book "Liberty's Best Hope" and followed up with "Rebound," a roadmap for the nation to bounce back from a perceived decline by reconnecting with the roots of its greatness.

"As a historian, diplomat, policy expert, author, and skilled manager, Kim Holmes has served The Heritage Foundation, the conservative movement, and our nation with distinction," James said when Holmes retired. "His wise counsel and institutional experience were invaluable to me."

On the news that this powerhouse team would step down to make way for new leadership at Heritage, Barb Van Andel-Gaby said, "Their tireless dedication to Heritage has taken the organization to new heights, led to numerous accomplishments, and positioned the Heritage team to be ready for the battles ahead."







NEW ADDITIONS TO HERITAGE'S LEADERSHIP TEAM

resident Kevin Roberts moved quickly to rebuild Heritage's leadership team, naming a new executive vice president, chief operating officer, and vice president of domestic policy.

Derrick Morgan returned to Heritage as the organization's executive vice president. Prior to this role, Morgan served as senior vice president for federal and regulatory affairs at American Fuel & Petrochemical Manufacturers (AFPM), where he oversaw government relations, regulatory affairs, and petrochemical departments. A Heritage alum, Morgan was vice president of Heritage's Institute for Economic Freedom and chief of staff to former Heritage President Ed Feulner. Before joining AFPM, Morgan served as Sen. Ben Sasse's chief of staff.

Eric Korsvall, who has been with Heritage for more than two decades, is Heritage's chief operating officer. In this newly established role, Korsvall manages day-to-day operations, as well as all aspects of Heritage's workforce. Korsvall's leadership has been critical in expanding Heritage's strategic presence and capabilities on Capitol Hill, and ensuring Heritage influence on public policy through timely and impactful events and public programs. As COO, Korsvall continues to manage these daily operations, while also working

to grow and expand the conservative movement by increasing Heritage's investment in the next generation of conservative leaders.

Roger Severino rejoined Heritage as the vice president of domestic policy. Severino was previously the director of Heritage's DeVos Center for Religion and Civil Society from 2015-2017, where he led research and policy efforts on pro-life, family, and religious freedom issues. He joined the Trump administration in 2017 as director of the Office for Civil Rights at the U.S. Department of Health and Human Services, leading a team of 250 individuals charged with enforcing U.S. civil rights, religious freedom, and health information privacy laws. Most recently, Severino was a senior fellow at the Ethics and Public Policy Center (EPPC).

"As Heritage's esteemed founder and former president Ed Feulner so often said, people are policy," Roberts said. "The core of Heritage's strength is not just the ideas and values we espouse, but the men and women who live them out on a daily basis."

MAKING OUR ELECTIONS MORE SECURE

n early January 2022, House Speaker Nancy Pelosi decried efforts by state governments to protect voters from election fraud, likening them to the protest at the U.S. Capitol the year before.

"What the Republicans are doing across the country," she said, "is really a legislative continuation of what they did on Jan. 6, which is to undermine our democracy, to undermine the integrity of our elections, to undermine the voting power, which is the essence of a democracy."

None of what Pelosi said is true. What is true is that Heritage played a key role in providing the data and the policy proposals behind those bills, educating state leaders on their merits, and defending them against unfair attacks like those uttered by Pelosi. As the New York Times reported early in 2021, "Of the 68 bills pertaining to voting, at least 23 had similar language or were firmly rooted in

the principles laid out in the Heritage group's ... extensive report." The sponsor of an Arizona reform bill, the Times went on, thanked Heritage "in a Facebook post after it passed."




been extremely active lobbying for reforms in key battleground states where the temptation to commit fraud is greatest.

At the end of 2021, your support helped us take our fight to the next level with the first-ever Election Integrity Scorecard—one of the most important research products Heritage has published. This interactive tool ranks all 50 states and the District of Columbia on how well their election laws protect the sanctity of votes. The scorecard reflects all stages of the electoral cycle from registration to voter/electoral certification. Importantly, it also includes model bills for shoring up election vulnerabilities under 12 identified categories.

As it turns out, almost all of the states at the bottom of the election integrity list are left-leaning ones, which might help explain why the left is so adamant that election fraud is a myth.

Hans von Spakovsky, manager of the Election Law Reform Initiative and senior legal fellow in the Edwin Meese III Center for Legal and Judicial Studies, put it best: "Americans need and deserve a system in which it is easy to vote and hard to cheat."

That's a sentiment that everyone—left, right, and center—should agree on. With the scorecard, we are providing the lever to grassroots activists, state legislators, and to you and your neighbors to fix your state election laws.



The Diversity Delusion at Schools

chools at all levels have been on a hiring binge lately. No, they aren't hiring more teachers or professors. To keep up with the never-ending demands of the "woke" crowd, educators have been adding "diversity, equity, and inclusion" staff.

Jay Greene, Ph.D., a senior research fellow at the Center for Education Policy, documented this trend with research showing how many DEI staff are employed by colleges and K-12 schools around the country, and what, exactly, this bureaucratic bloat accomplishes.

The results have been nothing short of jaw-dropping. At the 65 universities Greene studied, DEI staff outnumbered history professors by almost 2 to 1. The University of Michigan has 5.8 diversity officials for every 100 faculty members.

Greene turned all this data into an interactive database that lets you see just how much DEI bloat there is at your alma mater.

Greene followed this up with a study looking at "chief diversity officers" at public K-12 schools and found that 79 percent of school districts with 100,000 or more students now have a CDO.

But all this DEI bloat is doing nothing to improve student satisfaction at colleges or reduce gaps between black and white children in public schools, Greene found.



Worse still, Greene found a shockingly high degree of antisemitism among the very people whose job it is to make these institutions more tolerant and more inclusive.

Greene's work sparked a wave of news coverage, with the New York Post's editorial board saying: "Kudos to the Heritage Foundation worker who pinned down crystalclear evidence of ugly bias among those pushing 'diversity, equity, and inclusion.'"

DRIVING FREEDOM OF CHOICE IN EDUCATION

ast year was eye-opening for anyone who cares about the future of this nation, as COVID exposed to millions of parents—and grandparents—just how callous public schools had become.

They saw how indifferent schools were to the needs of children, how beholden to teachers' unions they were, and, worst of all, how many were run by leftist bureaucrats who'd turned schools into indoctrination camps bent on undermining your values.

This realization led to a widely covered revolt in Virginia, where parents elected a Republican governor for the first time in 12 years, and it caused parents across the country who could afford it to put their children in private schools or homeschool them. But it also prompted a sweeping education reform in West Virginia that got much less attention, yet will empower every family in the state to fight back. It's a reform that your support of Heritage was directly responsible for making a reality.

Here, briefly, is how it came about.

In 2016, Jonathan Butcher, the Will Skillman Fellow in education, published the first report to ever make the case for a reform in West Virginia, called education savings accounts. He followed that report up with additional research and testimony before the West Virginia House of Delegates. Butcher continued to actively work with the Cardinal Institute, a conservative think tank in the state, to promote the idea.

ESAs—an idea that originated with Heritage scholars—aren't like school vouchers, which parents can only use at another school. These savings accounts bring true freedom to families, because they can use the funds to pay tutors, cover homeschooling costs, and other education services specific to their child.

In the spring of 2021, all that spadework paid off. West Virginia Gov. Jim Justice signed a bill enacting the most sweeping education choice plan in the country. Starting this fall, all families with students currently enrolled in public schools will be able to access up to \$4,600 of state education funds if they decide to seek other options.

That means starting in the fall of 2022, no West Virginia child will have to remain stuck in a school that fails to meet their needs. No parent will be forced to watch their tax dollars used to undermine their values. Teachers' unions will no longer be able to hold West Virginia families hostage.

"Parents have a right to be in control of their children's education," says Lindsey Burke, Ph.D., director of Heritage's Center for Education Policy and the Mark A. Kolokotrones fellow in education. "West Virginia has shown that this can be a reality."

So how do we expand education freedom to the rest of the country?

With your support, Heritage in 2022 is undertaking a game-changing product, tentatively called the Index of Education Freedom, which will rank states based on several measures of freedom, from school choice opportunities, state regulations, open enrollment at public schools, and more.

ENDING THE THREAT OF COMMUNIST CHINA

hile the left kept its head buried in the sand, The Heritage Foundation was actively working on your behalf to expose the increasing threats posed by Communist China to its own people, to the region, to the United States, and to freedom-loving people everywhere.

"China represents the single biggest challenge to American interests in the world," said Asian Studies Center Director Walter Lohman. By the end of the year, China's malignant behavior was apparent to everyone with eyes to see.

You helped us point out the fact that Chinese Communist Party (CCP) members had infiltrated a host of U.S. universities and businesses and that supposedly private Chinese companies were effectively arms of the CCP. You kept the public aware of China's increasingly aggressive and belligerent actions in the region, particularly against Taiwan, and its serial lies about COVID-19.

Your support also produced a vital new resource last year called the China Transparency Report. This comprehensive guide helps policymakers assess the current state of the CCP's global ambitions. China's lack of transparency in these areas is a significant problem, one that isn't likely to change. So, to help fill this gap, the report collects data from dozens of partner organizations worldwide.

"To address China effectively," Lohman explained, "policymakers—as well as the public—need the best information available. We've worked with dozens of organizations around the world to bring it all under one cover."



Saving Lives, Halfway Around the World

t Heritage, having an impact on events doesn't just mean advancing the right public policies. It can also mean using our talent, skills, and experience to save lives—literally. In his new book, "Winning in a Socially Networked World," James Carafano, vice president of the Kathryn and Shelby Cullom Davis Institute for National Security and Foreign Policy and the E.W. Richardson fellow, recounts how he leveraged his long list of worldwide contacts to help hundreds who were desperately trying to flee Afghanistan after the Taliban took over. The following is excerpted from the book's prologue.

It all started with an email from an old friend and mentor who served on the board of the Center for International Private Enterprise. His request was, "Help."

Afghanistan was a half-a-world away in an opposite time zone, mired in absolute chaos and conflict. Helping from a computer in Washington, D.C., seemed a forlorn hope. But, when friends ask—you answer.

Riffling through my Outlook contact list produced about a half-dozen email addresses of nongovernmental organization representatives, former government officials, journalists, policy analysts, activists, and retired military—a wish list of folks who I figured might know something, someone, or have a clue of whom to ask.

To my great surprise, the emails triggered a small hyperactive network, folks rushing to save lives before it was too late.

In less than a day, what became a global network of volunteers, many of whom didn't know each other before the crisis, effectively linked federal agencies, foreign governments, NGOs like Spirit of America, commercial charter plane companies, special forces veterans, a former yoga instructor, philanthropists, journalists, random do-gooders, a well-known writer of spy and political thrillers,

and all kinds of other folks from all over the country, all over the world.

What these folks achieved was extraordinary. The collapse of Afghanistan, the resurgence of the Taliban, and the haphazard withdrawal were a humiliating setback for the U.S. government. If not, however, for the incredible individual efforts of so many, from so many countries, assisting in the evacuation, the disaster could have been far worse.

There is no question that some people got help who likely would now be dead if not for the chance connections of emails flying across the internet.






As China continues its rise, the actions of the Chinese Communist Party have implications across the globe. The need for transparency is increasingly important. Even before the COVID-19 pandemic, the CCP has often withheld, obfuscated, and falsified data for its own purposes. Above all, where you clearly had an influence was on the issue of China's horrific abuse of the Uyghur people and the need for the U.S. to forcefully respond to it. Few experts wrote as widely or as passionately about the plight of the Uyghurs as Olivia Enos, senior policy analyst at the Asian Studies Center. Last spring, the U.S. Commission on International Freedom called on Enos to testify about the horrific human rights abuses and genocide facing the Uyghurs, and in October, she testified again—this time before the Congressional-Executive Commission on China.

In part because of her work, Rep. James McGovern, D-Mass., introduced the bipartisan "Uyghur Forced Labor Prevention Act" in the House last year, and Sen. Marco Rubio, R-Fla., introduced a version of that bill in the Senate. At Rubio's urging, the bill passed both houses, despite the deplorable efforts by the Biden administration to block it. The president didn't want the bill to disrupt its climate talks with Beijing. Enos called the new law "a direct, necessary response to some of the CCP's most evil behavior, and also to the lackluster use of existing tools by the Biden administration."



STANDING UP FOR LIFE

A bortion is an issue that many public policy organizations—including some that identify as conservative—would prefer to ignore.

However, at Heritage, we recognize that every human life, born and unborn, has innate dignity and value and is worthy of protection. To ignore the plight of the most innocent in our society is simply unconscionable.

With your support, The Heritage Foundation has spoken out boldly in defense of life and fought for policies that protect both mothers and their babies. One area in the fight for life where your efforts have made considerable impact is in the courts. For the first time since 1973 (when the unjust and misguided Roe v. Wade decision was handed down), America has a chance to right the many wrongs abortion-on-demand has brought to our country. The Dobbs case, currently being considered by the court, is the most significant chance to shift pro-life policy in over four decades.

This is only possible because you were instrumental in getting Justice Amy Coney Barrett confirmed to the Supreme Court, replacing the liberal Ruth Bader Ginsburg and giving conservatives a clear majority on the court. Our legal experts recommended Barrett as a potential candidate to President Trump. Following her nomination, Heritage worked to educate the public and Congress on Barrett's character and judicial beliefs and expose the lies told by her critics. Heritage experts produced dozens of op-eds, held events, and even launched a seven-figure ad campaign to promote her confirmation. Without your advocacy for conservative justices, it is unlikely the Dobbs case would have ever been heard by the court.

No matter the outcome of the Dobbs case, which at this writing still hasn't been decided, we will continue your fight for life on a multitude of fronts, especially at the state level. Heritage Policy Analyst Melanie Israel spoke at a rally for Dobbs outside the Supreme Court in December. Heritage saw a bill introduced in Congress that reflected our work-Protecting Life on College Campus Act of 2021 (H.R.4607). Meanwhile, seven states (Montana, Texas, Oklahoma, Indiana, North Dakota, Arizona, and Arkansas) took steps administratively or legislatively to strengthen regulation of abortion pills, an issue you helped bring to life and on which we worked with a national coalition to develop model legislation.

The right to life is precious and inalienable, and you can trust that The Heritage Foundation will not rest until it is protected in law.

Former Heritage Intern Leads the Fight to Protect the Unborn

hen the Supreme Court heard arguments in the Dobbs case, it was thanks in part to one woman who has been a key figure leading the charge to overturn Roe v. Wade: Marjorie Dannenfelser, president of the Susan B. Anthony List (SBA). Marjorie got her start as a Heritage intern.

The SBA List is a nationally renowned political group dedicated to ending abortion by electing national leaders and advocating for laws that save lives. The SBA List has helped elect more than 100 pro-life leaders to Congress and dozens to statewide offices.

Marjorie was an intern in Heritage's Young Leaders Program, which recruits and trains promising young people and has launched the careers of many prominent conservative leaders.

Her internship, Marjorie says, directly influenced the course her life and work took. She says that when she entered the YLP back in 1986, she was firmly pro-choice, but opened her heart to the unborn after the education she received and the people she met at Heritage.

"The consequence of that deep change," she says, "led to the founding of the Susan B. Anthony List."

Marjorie is one of our country's premier pro-life advocates. She has been named one of Newsmax's Top 25 Influential Republican Women, one of Politico Magazine's Top 50 Influencers, and served as national co-chair of Pro-Life Voices for Trump.

magine an ideology that tells your child that, simply because of their skin color, they are an oppressor, who is guilty of serious injustices against groups of people going back generations.

Or, this ideology might tell your child that, because of their skin color, they are a victim, destined to fail because an unfair society will never let them succeed.

If this ideology sounds familiar to you, it's because it has already spread throughout our country. It's called critical race theory (CRT), and you are helping The Heritage Foundation to defeat it wherever we can.

At its core, CRT is a Marxist ideology that has seeped into many of America's public institutions. It's especially pervasive in America's schools, where the campaign to rewrite history and depict the U.S. as irredeemably racist is the fiercest. Its goal isn't to end racism but to remake our society to fit the leftist agenda and reintroduce racial discrimination into our culture.

By supporting Heritage, you were an early and outspoken opponent of critical race theory, and you fearlessly fought back with the truth. Together, we used the breadth of our expertise in law, education policy, history, policy formulation, storytelling, convening, and investigative reporting to expose CRT for what it really is.

You also went on offense in this fight and took the battle right to the states. Over the past year, Heritage policy experts helped draft model legislation to protect state institutions and K-12 schools from CRT.

In 2021, Heritage senior fellows Jonathan Butcher and Mike Gonzalez both testified about the nature of CRT before the Louisiana state legislature while Gonzalez also testified before the Subcommittee on







On Offense Against CRT in the Media

s part of Heritage, you were a leader in the fight against CRT, especially through a creative, sustained, and aggressive media strategy.

When NBC's Brandy Zadrozny attacked Heritage for our role in supporting the anti-CRT movement and criticized parents for filing FOIA requests with their school districts, we executed a rapid-response campaign on social media, tweeting the video in a comprehensive thread taking down her claims.

The video and our response received hundreds of thousands of views and generated numerous stories, including in Fox News, The Federalist, and Daily Wire. The response was critical in showing the elitism of CRT proponents.

The National Education Association also attacked Heritage by name because of our CRT work, to which we hit back with social media posts that drew massive media attention, including coverage on Education Week, Newsmax, Ben Shapiro Show, Fox News, National Review, Epoch Times, Daily Caller, and more. It also prompted several days of negative coverage for the teachers' union.

And when the NEA tried to scrub the item from its website, we caught them red-handed and made another news cycle out of it.

These initiatives alone resulted in 164 broadcast hits and 336 print mentions in 2021. It's a case study in how, with Heritage, you are always on offense against the radical left's agenda.

Civil Rights and Civil Liberties in the U.S. House of Representatives. Butcher and Gonzalez crisscrossed the country speaking on this issue to legislators, universities, conservative allies, education associations, and parent groups.

The Heritage Foundation also hosted a major event highlighting the dangers of CRT, "The New Intolerance: Critical Race Theory and Its Grip on America," and Butcher published a new book, "Splintered: Critical Race Theory and the Progressive War on Truth," which makes clear how CRT has hijacked the U.S. education system.

As of this writing, 26 state legislatures have introduced bills to remove critical race theory from their state institutions and K-12 schools.

We also published an e-book on CRT, and thanks to your help, we have distributed thousands of copies of this e-book to educate voters on how to spot CRT in their communities: bit.ly/3oS5ulX.

SCORING A MAJOR WIN FOR FREEDOM

hen we say "always on offense," you can believe that we mean it, and nothing showcases this better than Heritage's first-ever lawsuit against the federal government to block the Biden administration's draconian—and illegal—vaccine mandate on employers.

Heritage's legal scholars had already done yeoman's work on your behalf explaining how the Occupational Safety and Health Administration (OSHA) had no legal authority to enforce this mandate, including a report in the peer-reviewed Administrative Law Review.

But implications of this mandate were too profound to simply complain about it and hope for the best. If left standing, President Biden's mandate would have opened the floodgates to federal intervention in every corner of our lives. If the government can force Americans to undergo a medical procedure of uncertain merit, what can't they do? This is why, in a Nov. 29 statement announcing the lawsuit, Heritage President Kevin Roberts called the Biden mandate "a deadly serious threat to our individual liberty and the values that make America great."

Heritage retained the American Center for Law and Justice to represent us in this matter, whose chief counsel, Jay Sekulow, defended President Trump during his first impeachment trial.

Our case, along with many others filed to block this mandate, ended up in the 6th U.S. Circuit Court of Appeals, which denied the stay. So, we appealed to the U.S. Supreme Court to keep the mandate from going into effect until there was a final ruling on its legal merits.

On Jan. 13, 2022, the Supreme Court did the right thing and kept the mandate from going into effect, suggesting that the mandate would not likely survive a ruling on the merits because Congress had never given OSHA the power to mandate "vaccination of 84 million Americans, selected simply because they work for employers with more than 100 employees."

In his appearance on the "Jay Sekulow Live" show, Roberts responded to this major victory by saying, "We're ecstatic because it is a line in the sand against the Biden regime that they better not cross again."

Your influence on this case extends beyond Heritage's scholarly work and litigation to the fact that you helped tilt the balance of the Supreme Court in favor of justices who see their job as interpreting the Constitution as written, not imposing a liberal agenda from the bench. There's no telling how this mandate would have ended up if conservatives didn't have a majority on the court.

RESEARCH THAT REVERBERATES AROUND THE WORLD

ne of the great strengths of The Heritage Foundation that you make possible is the ability to pull together vast amounts of data on the most important issues of the day and present them in highly influential reports.

Two of these are the Index of Economic Freedom and the Index of U.S. Military Strength.

The Index of Economic Freedom collects data on 12 measures of economic freedom from 184 countries, analyzes this data, and ranks these nations based on the results. The index provides definitive proof of the benefits of limited government, free markets, the rule of law, and prudent fiscal policies because it consistently shows a direct connection between freedom and prosperity.

The index doesn't just influence policy debates here in the U.S.; its rankings can rankle the leaders of nations. Such was the case when the index dropped Hong Kong as a separate country. Hong Kong had held the No. 1 spot in the world in every one of the index's 25 years, until it fell into second place behind Singapore in 2020. The next year, the editors removed Hong Kong altogether from the list in the wake of Communist China's increased interference.

That didn't sit well with Hong Kong officials. In fact, Hong Kong's finance secretary, Paul Chan, attacked our decision to remove Hong Kong's standalone ranking.

"When they arrived at that decision, they must have been clouded by their ideological inclination and





political bias," Chan said, according to Radio Television Hong Kong.

Another highly influential publication you make possible is the Index of U.S. Military Strength, which provides a detailed assessment of the readiness of every branch of the military. It is without question the most authoritative unclassified reference for information on the U.S. military.

The eighth edition, which runs 587 pages and was published in October, notes storm clouds on the horizon as President Biden proposes to underfund several key capabilities. It also includes a new chapter on cyber security and brand-new scoring for the U.S. Space Force. Asia, and the China threat in particular, figures prominently in the report.

The launch event featured Rep. Mike Rogers, R-Ala., who is the ranking member of the House Armed Services Committee and one of the leading voices in Congress for a strong national defense. At that event, Rogers said, "The 2022 Index of U.S. Military Strength could not have come at a better time. As a policymaker, I rely on the insights of experts such as the scholars here at Heritage. With the index, I can contemplate what some of the best thinkers have to say about the U.S. military. I'm constantly looking for conservative insights into how Congress can further strengthen our national defense. Please know that the work you produce will help shape the policy that I will put forward and the oversight that I will conduct as chairman of the House Armed Services Committee after next November."

Added to this list of publications is the China Transparency Report, the first of which was published last year and measures China's transparency across eight different sectors.

"The Chinese government has a history of withholding, manipulating, and falsifying data for its own purposes," says Walter Lohman, director of The Heritage Foundation's Asian Studies Center. He adds that this independent data "exposes areas where China poses the greatest threat to U.S. interests, and examines where threats are overstated."

Also added to the list of major publications in 2021 was the Election Integrity Scorecard (see page 10). We also brought forth the interactive "Essential Constitution" e-book, which explores the U.S. Constitution's origins, busts myths, examines threats, and includes a primer on how to interpret this seminal document. An accompanying website includes a host of resources for anyone wanting to understand America's founding:

Reaching Audiences Where They Are

big part of staying on offense is adapting to changes on the field. That's nowhere more important than in communications, where there has been an absolute upheaval in how people get information. When not fighting Big Tech, you're helping us expand our reach on social media, whether it's Twitter, Facebook, YouTube, or other platforms.

One big way you're reaching new audiences is through our growing stable of influential podcasts, which now features "The Kevin Roberts Show," hosted by our new president.

Another increasingly popular show is "The Daily Signal Podcast," hosted by Virginia Allen, Doug Blair, and Rob Bluey. Each weekday, the podcast shares leading headlines being covered in Heritage's news outlet, The Daily Signal, and provides smart and sophisticated commentary on what's important.

Last year, "The Daily Signal Podcast" generated more than 2 million listens. The most popular episode of the year focused on former New York Gov. Andrew Cuomo's attempt to cover up the vast number of COVID deaths in nursing homes in his state. The second most popular was on the plight of overwhelmed Border Patrol agents.

"The Daily Signal Podcast" guest list is a veritable who's who of lawmakers, leaders in the conservative movement, and scholars inside and outside Heritage.



TAKING ON BIG TECH

t's no secret that Big Tech companies actively discriminate against conservative voices and viewpoints.

While conservatives used to be hard pressed to present hard evidence of this discrimination, Heritage has done major work to shine a light on the truth—arming you in the battle against the dangerous, politically motivated censorship by these behemoths.

In her testimony before a U.S. House committee recently, Heritage research fellow and former Facebook employee Kara Frederick put it bluntly, calling Big Tech "an enemy of the people." In May 2021, Heritage signed a pledge along with other

conservative leaders calling out Big Tech censorship and refusing to accept contributions from them.

Addressing this threat has been and will continue to be a priority for Heritage going forward. We are recommending that Congress update Section 230 of the 26-year-old Communications Decency Act, which currently provides Big Tech with blanket liability immunity. Lawmakers wanted to incentivize these platforms to improve communication, not silence political dissent.

We are also helping to shape state legislation regarding Big Tech censorship. And since the public helped grow these tech platforms into what they are, it makes sense that the public ought to be the ones to bring them back in line. You need to be able to see—and understand—the platforms' rules and terms of service. And you need to know your rights. What recourse do you have if your account is taken down or labeled? And most importantly, are these monopolists even following their own rules?

Heritage is taking your fight for free expression to the next level. Thanks to your support, Frederick has been able to gather up hard data on how malicious these companies have become. You deserve better. The nation deserves better.

FROM THE REPORT:

- A 2019 study found that Twitter suspended users in the "conservative" category at a ratio of 21-to-1 compared to "liberals."
- Twitter and Facebook censor Republican members of Congress at a rate of 53-to-1 compared to Democrats in Congress.
- In 2020, Google suppressed conservative-leaning outlets such as the Daily Caller, Breitbart, and The Federalist. For instance, Breitbart's Google search visibility shrank by 99 percent during the 2020 presidential election cycle compared to the same period in 2016.
- ➤ Facebook created and used two internal tools in the aftermath of Donald Trump's 2016 electoral victory that suppressed right-wing content, media traffic, and reach on the site. One of these tools was still in use by Facebook as of October 2021.

Heritage Feels Big Tech's Sting

Stories of Big Tech censorship of conservative content and conservative politicians are legion. Heritage is not immune from their efforts to squelch speech they don't like.

Examples from the past year include:

- In September 2021, Amazon prohibited ads promoting Heritage scholar Mike Gonzalez's book criticizing the Black Lives Matter organization and its relationship to Marxism.
- In March 2021, Amazon revealed that it removed scholar Ryan T. Anderson's book on gender dysphoria, written while he was a senior research fellow at Heritage. Amazon banned the book, "When Harry Became Sally," three years after publication because it allegedly violated Amazon's content policy.
- In September 2021, Twitter censored a Daily Signal video documenting the work of mounted Border Patrol agents. The video, shot and published in 2017, highlights how horses help the U.S. Border Patrol secure the border. When we reposted the video in the wake of a debunked story about agents on horseback whipping illegal immigrants, Twitter slapped a warning label on it: "The following media includes potentially sensitive content."

We had the media clout to get the tech giants to respond and in some cases back off, but not every conservative does. That's why in early 2022, Heritage released a comprehensive list of reforms needed to rein in Big Tech.



CHANGING THE MEDIA NARRATIVE ON THE BORDER CRISIS

oon after Joe Biden took office, the border was overrun by illegal immigrants, a story that the administration and the liberal media were happy to downplay or ignore.

But that was impossible thanks to you and your support of The Heritage Foundation.

Together, we were able to mount a media blitz that kept the story alive, exposed the dire humanitarian crisis the Biden administration had unleashed, and held the current leadership to account for this unprecedented crisis.

You knew as well as we did that illegal immigrants would flood across the border if the open-borders crowd gained control of Congress and the White House. In anticipation of that, we recruited three veterans of the Trump administration who have unmatched expertise

on border security: Chad Wolf, secretary of the U.S. Department of Homeland Security; Ken Cuccinelli, deputy secretary of the U.S. Department of Homeland Security; and Mark Morgan, commissioner of U.S. Customs and Border Protection.

Between the three of them, they made nearly 500 national broadcast segments in 2021, including nearly 200 in their first three months as Heritage visiting fellows.

Their constant media presence helped build and expand the border crisis narrative, which was a constant story throughout 2021.

Making It Personal

espite the left's control of the White House and Congress, the Institute for Economic Freedom scored several victories in 2021.

The Institute's research, op-eds, media presence, and close relations on Capitol Hill, for example, were instrumental in blocking President Biden's \$4 trillion "Build Back Better" disaster. Our work exposed this bill for what it was—a radical leftist ploy to vastly expand the federal welfare state that no Republican or centrist Democrat should support.

We were also key in keeping another policy disaster—the \$15 minimum wage—out of Biden's "American Rescue Plan." This success comes not just through the quality of our research, but our ability to show the real-world impact of the left's policies.

Rachel Greszler, a research fellow in economics, budget, and entitlements in the Institute for Economic Freedom, knows how effective this is. So, when she's making her case, she doesn't just gather the data, she does the hard work of finding real people to share their stories.

For example, Greszler hosted a public event featuring restaurant owners and workers (most of whom were liberal) about why doubling the federal minimum wage was a bad idea. When she testified before Congress on the issue, she shared the views of several business owners, one of whom told her, "I am a staunch supporter of

Joe Biden and voted for him to save this country. Now I ask him to save my restaurant from the good intentions of progressive policymakers."

To explain why the federal COVID unemployment bonus discouraged people from returning to work, she produced a video with The Daily Signal about how the resulting worker shortage was harming a person with disabilities.

To fight the PRO Act, a union-backed bill that would harm independent contractors, Greszler shared stories about working women who would be harmed by the bill, including a "Mercedesdriving grandmother in San Antonio, [who] was driving an Uber as a way to earn extra money to help send her grandchildren to parochial school."

This is what you are accomplishing. Real stories. Real impact.

In tandem with this, Heritage's media and public relations team released regular statements in response to Border Patrol's monthly reports on border crossings, which were skyrocketing throughout the year. They hosted two national press briefings on the crisis and produced five fact-checks of Biden administration officials' statements that were well-received in the media, including a plug on Sean Hannity's show and his website: "[The] Heritage Foundation fact-checked Biden's bogus claim about the border when he said the expulsion of single adults did not pose an operational challenge for the Border Patrol."

We also used social media to advance the border crisis narrative, doing rapid response when Press Secretary Jen Psaki accidentally called the border crisis a "crisis," and sharing photos of overcrowded Border Patrol facilities.

All told, Heritage experts were featured in 784 total broadcast segments about the border, roughly 15 percent of all Heritage broadcast hits for the year, and secured more than 260 print mentions on the issue, as well.

Simply put, you forced the press to pay attention.
